Mr. Ibrahim Qureshi informed the members that for Budget 2009-2010 proposals were sent to the concerned ministries through Lahore Chamber of Commerce and Industry and Federation of Pakistan Chamber of Commerce and Industry. But since proposals were sent by only very few companies, it was not a comprehensive effort. He further added that in the future the members of ABF should work in a more systematic manner for which we would require feedback from all members in shape of their concerns with Federal and Provincial Government.

A presentation regarding **USAID** on going programs was made by Mr. Sajjad. He suggested the members to become their partner in these development fields. He further mentioned that after the **mobilization phase**, their targets would be more specific which would be addressed with the help of Provincial Government.

President ABF, Mr. Rizwan Ullah Khan introduced **Dr. Rao Tawwab Khan** who initiated the monumental project of school for special children with the help and support of his wife. He appreciated the efforts of the entire team who have helped in making this project successful and magnanimous. This was followed by Mr. Tawwab's presentation that focused on the services Rising Sun is offering and shared a few of their success stories. After the presentation, Mr. Rizwan requested the members to sponsor at least one child which costs the institute Rs. 5000 per month for a period of one year. He himself announced the sponsorship of 10 children for a year, while Echo West and Hardees sponsored 5 children and other also pledged to contribute.
